



Waiver and Release of Liability

I hereby give permission for me/my child(ren) to participate in Chicago Park District activities, including but not limited to Chicago Park District programming, summer camp, swimming, field trips, and internet-based park programming offered via third-party video and/or audio-conferencing platforms (collectively, the "Park Activities"). I agree that I will hold the Chicago Park District, its employees, Board of Commissioners, officers, representatives, coaches, volunteers, sponsors, private partners, including but not limited to Special Children's Charities, public partners including but not limited to Chicago Park District sister agencies including but not limited to, Chicago Public Schools, Chicago Housing Authority, City of Chicago, and Chicago Park District agents (collectively, the "Park District Parties") harmless for any injuries or losses I and/or my minor child(ren) might sustain while participating in Park Activities, whether in person, via telephone, over the internet, or while traveling to or from said Park Activities, and hereby release the Park District Parties from liability for any injury I or my child(ren) may sustain. I further agree to defend and indemnify the Park District Parties for any claims asserted on behalf of me or my child(ren), or in connection to my and/or their participation in Park Activities.

In the event of a medical emergency during Park Activities, except for those occurring during over third-party video and audio-conferencing platforms, I hereby authorize and give my consent to the Chicago Park District and its employees, coaches and/or volunteers to initiate treatment necessary for me or my child's immediate care including but not limited to ambulance transportation services and emergency room care. I agree that I shall remain responsible for any and all expenses incurred for such emergency medical care and treatment.

In the event that I request the Chicago Park District to administer oral medication to my child(ren) in accordance with the Chicago Park District's Medication Policy, and/or administer an inhaler to my child(ren) during certain times and frequency, and/or administer an EpiPen autoinjector as prescribed in writing on the child(ren)'s "Parent/Guardian Authorization For Emergency Care of Child With Severe Allergies", I accept and endorse the following terms and conditions pertaining to my request, I understand and accept that: 1. Chicago Park District and Park District Parties are not licensed health professionals; 2. I am responsible for supplying my child(ren)'s medications in original prescription bottles with dose(s) to be given, labeled with my child(ren)'s name for transport daily; 3. I am responsible for providing up-to-date information to the Chicago Park District regarding changes in my child(ren)'s medical condition, as well as changes that may affect the treatment; 4. I fully release, indemnify and defend the Chicago Park District and the Park District Parties from any and all liability for loss, damage, or injury, caused to my child(ren)'s person or property, or to me, as a consequence arising from administering the medication, failing to administer the medication correctly, and/or failing to administer any medication.

I agree to abide by the procedures and policies in the Program Information Sheets for Parents (for Summer Camp and PARK Kids) and the Chicago Park District's Facilities Users Code of Conduct.

I hereby grant permission to the Chicago Park District and the Park District Parties for the use of any and all photos, as well as video or sound recordings, in which I or my child(ren) may appear (wards of the State excluded). The usage is inclusive of, but not limited to, the publication or

inclusion in brochures, posters, websites, catalogs, handbooks, banners, and broadcast or print advertisements. I agree to waive any claim to compensation for use of said photos.

In keeping with the Illinois Children's Privacy Protection and Parental Empowerment Act, (325 ILCS 17/), the Chicago Park District will not sell or purchase a child's personal information without parental consent.
